

**TERMS AND CONDITIONS FOR

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this 'TELL US WHAT YOU LIKE BEST ABOUT WINTER SCHOOL HOLIDAYS IN TAREE' FOR YOUR CHANCE TO WIN A FAMILY PASS TO INFLATABLE WORLD AND A \$50.00 TAREE CENTRAL GIFT VOUCHER!' FACEBOOK COMPETITION ("Promotion") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local daylight savings time.
2. Subject to condition 3, this Promotion is only open to NSW residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. The following are ineligible: (i) employees of the Promoter (PPI Capital Ltd / Taree Central Shopping Centre trading as Taree Central), or any of the tenants or retailers in the Participating Centre or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto, spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

To receive an entry in this Promotion, eligible individuals must, during the Promotion Period, 'Like' the official Taree Central Facebook page, comment on the competition post with the answer to the following - 'Tell us about what you like best about winter in Taree' and "Share" this post between 19th – 23rd June 2021 to enter the draw. Five winners will be selected from the current competition post only. The "Share" must be visible to meet entry requirements.
6. It is a requirement of entry into the Promotion that the entrant agrees that their personal information can be used in accordance with these Terms and Conditions, including for the purposes set out in clause 22.
7. The winner will be notified via Facebook.
8. During the duration of the promotion, there will be five winners chosen. Each winner will receive the following prize:

1 x family pass to Inflatable World (4 x tickets – value \$60.00)
The prize is to be collected in person by the winner from the Centre Management Office of Taree Central, 60 Manning Street, Taree NSW 2430 during business hours Monday to Friday – photo identification must be shown. If the winner is unable to collect their prize, they must make alternative arrangements at their own expense (ie. postage).
