

**TERMS AND CONDITIONS FOR  
'WIN A CAR AT TAREE CENTRAL' COMPETITION**

1. Information on how to enter and the prize forms part of these Terms and Conditions. Participation in this 'WIN A CAR AT TAREE CENTRAL' Promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local daylight savings time.
2. Subject to condition 3, this Promotion is only open to NSW residents, 18 years old or over.
3. The following are ineligible: (i) employees of the Promoter (PPI Capital Ltd / Taree Central Shopping Centre trading as Taree Central (ii), or any of the tenants or retailers in the Participating Centre or any of the Promoter's agencies that are associated with the Promotion; (iii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iiii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.
4. This Promotion commences at 10.30am on 1<sup>st</sup> February 2024 and concludes at 9.00pm on 18<sup>th</sup> April 2024 ("Promotion Period"). Drawn 19<sup>th</sup> April 2024.
5. To receive an entry in this Promotion, eligible individuals must, during the Promotion Period, undertake the following steps:
  - a) Spend \$25 at any Taree Central fresh food retailer or eatery OR \$50 at any other Taree Central specialty retailer or \$100 at Big W or Woolworths at Taree Central during the Promotion Period excluding any Ineligible Transaction ("Qualifying Spend").
  - b) Request your receipt from the retailer, scan the QR code and fill out the required information including attaching a picture of your receipt on your smart device.
  - c) Customers may enter as many times as they would like but only once per valid receipt. Each entry must be submitted separately and in accordance with the entry requirements. An "Ineligible Transaction" means any transaction recorded on an invalid receipt, as specified in condition 6 below.
6. The following receipts are not valid receipts for the purpose of the Promotion: (a) receipt(s) from non-participating retailers and Excluded Retailers; (b) receipt(s) recording bill payments, lottery ticket and tobacco and tobacco related product purchases; (c) receipts recording Layby payments except where a Layby is finalised and payment completed during the Promotion Period; (d) receipts recording redemption of gift card purchases, store credit, refunds and exchanges; (e) ATM or EFTPOS receipts; (f) credit card or bank statements; and (g) receipt not meeting qualified spend amounts and (h) receipts that the Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts. The same purchase receipt can only be submitted once in the Promotion. The Promoter reserves the right to stamp and/or photocopy each purchase receipt submitted in the Promotion before returning them and to request to see a copy of the receipt should they be deemed a winner.
7. It is a requirement of entry into the Promotion that the entrant agrees that their personal information can be used in accordance with these Terms and Conditions, including for the purposes set out in clause 24.
8. The draw will take place in the Centre Management office of Taree Central, 60 Manning Street, Taree NSW 2430 on Friday 19<sup>th</sup> April, 2024. The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant.
9. The provisional winner will be notified by phone and email within 2 business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter. The winner will have their name and postcode published on the Centre's website once verified.

The first valid entry (this must have a valid receipt attached) drawn will be the major prize winner. The major prize winner will receive a Chery Omoda 5 in Titan Green OM51.5T2BX0A OMODA 5 1.5T CVT BX. The vehicle is drive away and includes 1 year registration, compulsory third party insurance, stamp duty and dealer delivery charges. If, for any reason, a winner does not take the prize or an element of the prize at the time stipulated, then the prize or that element of the prize will be forfeited and will not be redeemable for cash.

If any prize (or part of any prize) is unavailable due to reasons beyond the control of the Promoter, the Promoter in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
20. The Promoter's decision is final and no correspondence will be entered into.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and the PPI Capital Ltd / Taree Central Shopping Centre group of companies (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.
